After collection of your study packs/materials neither **Hardcopy/Softcopy** via your E-mail, you shall be assigned a personal OSHA Instructor, who will coach you whenever you have any challenge with your study or any question/explanation, still you take your examination, neither distance or classroom.
4. As an international professional course, all study materials given to you are the same worldwide, including the examination and you are expected to pass 70% mark on each of the course, for the award of the certificate.
